# DIRECTOR OF EDUCATIONAL PROGRAMS

## **DEFINITION**

Under the direction of the Chief Academic Officer, coordinates and implements State and Federal Categorical Programs and Projects; serves as an education leader and program coordinator in the planning, implementation, and evaluation of said projects and programs relative to student achievement; organizes and implements relative, ongoing District staff development program; and other related functions as directed including the Local Control Accountability Plan.

## EXAMPLES OF DUTIES

Provide leadership for all phases of the categorical programs, including the Local Control Accountability Plan related to student programs related to student achievement; coordinate and articulate the programs among all participating schools; plan and implement District categorical budget allocations for school sites, District centralized services and indirect costs for categorical budgets, including categorical salary allocations for personnel supporting the categorical programs; support principals with technical assistance for the categorical programs; plan and implement staff development components for the programs; coordinate with the Chief Academic Officer educational services to ensure program fiscal accountability; plan and implement the curriculum and material component of the program; maintain all necessary project records; disseminate information to District, community, state and federal agencies; act as a liaison to the State Department of Education; plan and coordinate compliance reviews; coordinate and evaluate effectiveness of supplementary programs, including school improvement program, categoricals, limited-English proficient, substance abuse prevention, and responsible decision-making curriculums. Organize, implement, and monitor the District Staff Development Program related to instructional services, state standards, curriculum delivery, and student support programs.
