DEFINITION

Under the direction of the Assistant Superintendent, Educational Services, assists in the planning, development, and implementation of various programs, including, but not limited to, Title I, Title VI, School Improvement, GATE, state and federal programs for English Learners, other School-Based Coordinated Programs; serves as a resource to District personnel and members of the educational community concerning the above issues; and to do other related functions as directed.

EXAMPLES OF DUTIES

- Provides leadership and assistance to schools in various program planning, implementation, and evaluation for Common Core, Technology Integration, and Early Literacy.
- Develops and/or acquires instructional materials for various programs for VAPA, STEM, debate, GATE, etc.
- Provides direction and guidance to schools to maintain ongoing compliance with state and federal program requirements.
- Plans and provides staff development to District certificated and classified personnel and parents on Common Core, Technology Integration, and Early Literacy.
- Assists in the coordination and dissemination of information relative to respective groups for various district committees and advisory groups.
- Helps analyze data from state and district assessments and provides reports for school sites and district personnel.
- Supports and assists schools in administration of district benchmark testing, diagnostic assessments, and SBAC.
- Provides assistance to school staffs in supporting At-Risk students, appropriate program placement, and analyzing assessment results.
- Conducts demonstration lessons in classrooms using the integration of technology.
- Represents the District at meetings pertaining to these programs.
- Assists with development of curriculum for departmental programs at Buena Park Junior High School.
- Maintains and ensures implementation of federal and state regulations and District policies and procedures governing Title I, Title VI, School Improvement, state and federal programs, GATE, etc.
- Performs other duties as assigned.
